3. **STORM DRAINAGE SDC'S - SINGLE FAMILY RESIDENTIAL: Resolution 13-12**

The impervious area capacity impact is based on 3,121 square feet (SF) for an average single-family residence in the City of Silverton. The added cost of off-sight capacity from the above information is:

**STORM DRAINAGE SDC'S - MULTI-FAMILY RESIDENTIAL: Resolution 13-12**

Since multi-family units have a typically higher percentage of impervious area per lot area, the cost of added capacity will be determined on a case by case basis. SDC's shall be calculated by dividing the total impervious area of the development including all paved and concrete areas and all roof areas of structures by 3,121 SF resulting in a factor. This factor will be multiplied by the SDC's for a single-family dwelling unit to determine the total SDC's owed. Detention is required for all developments with an impervious surface greater than 10,000 SF and all detention facilities shall be engineered and meet all City standards for design and construction. Detention is a requirement and no SDC reductions for detention will be granted.
