#### IV. SCHEDULED PRESENTATION

Travis Comfort Republic Services Representative presented the Recycle Motorization Act, and presentation included discussion on items below:

- Per Mr. Comfort the State of Oregon began Recycling 41 years ago. Recycling goals were unfortunately not met causing DEQ to implement education and outreach requirements.
- Container requirements.
- Brief timeline of how the law passed/votes.
- Total waste and recycling generated in Oregon from 1992-2020.
- The state legislature directed DEQ to implement Senate Bill 582 and DEQ is currently in the rulemaking process.

- Uniformed Statewide Collection List- Sustainable Materials.
- Producer Responsible Organization, [PRO] List Harder to recycle list.
- PRO's responsibilities.
- The new system's goal is to become a Circular Economy.
- CAA- Timeline and Plan.
- DEQ Needs Assessment.
- PRO's Contamination Management Fees.
- DEQ's permit and certification process requirements.
- Outreach standards and public education covered by the PRO's.
- The City of Silverton's next step is a Detailed Needs Assessment due late Summer 2024.
