AN ORDINANCE OF THE SILVERTON CITY COUNCIL AMENDING SILVERTON MUNICIPAL CODE CHAPTERS 10.04 AND 10.24 TO UPDATE CODE LANGUAGE AND REMOVE FEE AMOUNTS

WHEREAS, it is the City's desire to establish a Master Fee Schedule; and

WHEREAS, removing the fee amounts from the Code altogether will make it easier for the City Council to update those amounts through resolutions on a more regular basis.

NOW, THEREFORE, THE CITY OF SILVERTON ORDAINS AS FOLLOWS:

Section 1: The Silverton Municipal Code is amended in substantially the same form as set forth in the attached Exhibit A (Sections 10.04.450 and 10.24.130).


Section 2: This ordinance is and shall be effective on July 1, 2020.

Exhibit A

10.04.450 Traffic violations – Impoundment and disposal conditions.

A. Whenever a traffic citation is issued, or a physical arrest made for a violation of Oregon's Vehicle Code, or local traffic regulations, and the driver of such motor vehicle is charged with Driving Under the Influence of Intoxicants, or does not possess a valid operator's license, or is driving on a suspended or revoked license or is without liability insurance required by the Oregon Vehicle Code, the vehicle shall, pursuant to city policy, be towed by a licensed towing company to the city impound lot, garage or other suitable storage place.

B. The owner of the impounded vehicle, or the owner's authorized agent, may redeem such vehicle upon payment of the towing bill *and a release fee set by resolution.* ~~, a \$50.00 impound fee and storage fees in the amount of \$10.00 per day commencing at 0001 hours on the day following the impounding of the vehicle. If redemption is not made within 30 days after the vehicle is impounded, then such vehicle shall be disposed of in accordance with the procedure provided by ordinance for the disposal of abandoned vehicles, or pursuant to ORS 819.210 through 819.260.~~ (Ord. 00-101, 2000; Ord. 89-101 § 1, 1989; Ord. 870 § 1, 1988; Ord. 860, 1987)

10.24.130 Fees and charges – Designated.

In the enforcement and execution of the provisions of this chapter, the chief of police shall charge and collect *fees set by resolution.* ~~the following charges:~~

A. ~~Ten dollars and fifty cents for towing, or, if a larger amount is charged by the towing service, then the amount of such charge;~~

B. ~~Seventy five cents per day for storage.~~ (Ord. 646 § 12, 1972)
