**A RESOLUTION OF THE SILVERTON CITY COUNCIL AMENDING WATER USER RATES AND CHARGES**

**WHEREAS**, Section 13.04.010 of the Silverton Municipal Code provides that water rates and charges may be changed at any time by resolution of the City Council; and

**WHEREAS**, the City Council of the City of Silverton desires to establish new water rates and charges in accordance with the following rate schedules and as provided in Section 13.04.015 of the Silverton Municipal City Code.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SILVERTON AS FOLLOWS:**

Section 1: Resolution No. 17-07 is repealed upon the effective date of September 10, 2019; and

Section 2: The Water Rates and Fees are established as provided below:

Effective July 1, 2024, the base charge, dwelling unit charge and the usage charge will adjust every July 1 according to the CPI-U as designated by City Council for the prior calendar year as of December.


All Fire Linc Rates are set at \$0.00 per month.
