CITY OF SILVERTON RESOLUTION 19-08

A RESOLUTION OF THE SILVERTON CITY COUNCIL ESTABLISHING ADJUSTMENT FOR THE STREET MAINTENANCE FEE (SMF); AND REPLACING RESOLUTIONS NO. 16-06 AND 17-06

WHEREAS, the Silverton City Council (Council) has authority pursuant to the City Charter and Silverton Municipal Code (SMC), Title 13, Utilities; Chapter 13.100, Street Maintenance Fee, to establish fees and other charges needed to pay costs associated with planning, management, construction, preservation, maintenance and where necessary, Chargen of City, owned or controlled streets (Street Maintenance) as a way to supplement other sources of revenue for those purposes; and

WHEREAS, Council believes it necessary and appropriate to adjust the monthly Street Maintenance fee annually according to the CPI as designated at the June 18, 2018 City Council Meeting-West Region Consumer Price Index, CPI-D annual average as of December.

NOW THEREFORE, BE IT RESOLVED BY THE CITY OF SILVERTON, AS FOLLOWS:

- Section 1: Effective July 1, 2019, the SMF will adjust every July 1 according to the CPI-U as designated by Cit Coancil for the pror calendar year as of December. The Responsible party for each Billing Unit on Developed Property shall be billed and is responsible for payment of this SMP as per SMC 13.100.
- As used in this resolution, "Billing Unit," "City," "City Utility Service," "Developed Property," Exproved," "Nonresidential Property," "Residential Property," and "Responsible Party" and shall have the meanings set out in SMC 13,000,020.
- Section 3: The SMF still be silled as follows:
 - (a) Single Family Residential Developed Property, an accessory dwelling unit and single occupant Nonresidential Developed Property shall each be treated as one (1) Billing Unit for the purpose of calculating this fee.
 - (b) Multi-family Residential Property, including but not limited to duplexes, apartment buildings, manufactured home parks and manufactured home subdivisions, shall be calculated by assuming that each separate Living Unit shall be counted and billed as one (1) Billing Unit. For example, the monthly fee for a 20 unit apartment complex would be 20 times the monthly fee.

- (c) For multi-tenant commercial or industrial properties, each tenant having a distinct and separate business or living unit shall be treated and charged as one (1) Billing Unit. For example, the monthly fee for a retail shopping center with 10 distinct businesses would be 10 times the monthly fee.
- (d) A motel, hotel or resort shall be calculated by assuming accident is part of the same Nonresidential Developed Property and shall be billed as one (1) Billing Unit. B&B's are included in this definition.
- (e) Institutional uses such as churches, schools and hospitals shall be billed as one (1) Billing Unit for each campus provided each structure on the particular campus is being used for in titutional purposes and not leased or rented to any third party. Structures leased or rented to any third party will be billed as a separate Billing that to the Responsible Party. Transitional housing units shar not be counted as a billing unit.
- Section 4. Any account with an unpaid SMF sent is a collection agency may be assessed an additional fee of \$25.
- Section 5: The City Manager may estroish additional plotocols/procedures for collection of the SMF and may use any method they decre reasonable and appropriate. Any protocols/procedures evablished under this section shall be reviewed and approved by the City Council before in planentation.
- Section 6: This resolution shall repeal Resolution No. 16-06 and Resolution No. 17-06 effective June 2 2019.
- Section 7: That this resolution is and shall be effective immediately after its passage by the Cit / Council.
